Newsflash: The Johannesburg Chamber of Commerce and Industry (JCCI) and the Cape Chamber of Commerce and Industry are the first within the Association of South African Chambers (ASAC) to receive the prestigious Certificates of Origin (CO) accreditation from the International Chamber of Commerce World Chamber Federation. This accreditation places ASAC globally recognised, ensuring that the COs they issue are trusted and credible. These certificates verify the origin of products and are essential for customs, trade agreements, and regulatory requirements, enhancing documentation reliability for international trade businesses.

Eskom plans to build a 100MW modular nuclear reactor as part of its broader strategy to replace decommissioned coal-fired power stations with renewable energy sources. This initiative is part of a ministerial determination to procure 2,500MW of new nuclear capacity. Eskom intends to develop battery and solar PV manufacturing capabilities to support this transition and the challenges posed by civil society groups opposing the nuclear energy procurement process. Through these projects, Eskom aims to ensure continuous economic activity and a stable energy supply, leveraging public-private partnerships for funding.
