Overstrand Executive Mayor keeps her promises -Dr Annelie Rabie-

The Overstrand Executive Mayor, Dr Annelie Rabie, visited Gansbaai on Tuesday, 22 February 2022 to react to various questions and concerns by community members and taxpayers - the tourism hall was fully packed with concerned community members. She seemed comfortable and confident and made it clear from the beginning that she was not going to provide any answers, "but that does not mean that you will not get any answers," she said in a friendly way.

"Behind me is a large number of my senior officials, as well as councillors," she said. "Every question and I mean every question, will be passed on to them for satisfactory answers." She then wrote down some categories of problems on a flipchart to be discussed.

During the next two hours of the meeting, it was clear that Dr Rabie meant what she said. She walked through the hall systematically from corner to corner with the microphone in her hand. Not a single question was ignored but passed on to a specific senior official or councillor to make a note of.

In September 2021 Dr Rabie also visited Gansbaai as the DA Mayoral Candidate for the Overstrand during a "Share a Sherry Hour" in Gansbaai Tourism Centre. Several promises of what she intended to do were made - but these promises were not the normal empty 'political' promises. It was clear that she meant every word she said, which now have been proven during the public meeting in February this year. She spent enough time answering several relevant questions by the guests and made notes of various aspects. It was clear that this was not only promising a good future in the Overstrand, but it was a passionate view on the future of the Overstrand. Some of the community members afterwards said they feel comfortable with the fact that the Overstrand Municipality is in good hands.

Vissermanne bietjie meer hoopvol

Die opvolgvergadering tussen 'n verkose vissermanskomitee en Cape Nature afgevaardigdes, is op Woensdag, 23 Februarie 2022 gehou. Hierdie vergadering het 2 dae na die volle vergadering van Maandag, 21 Februarie 2022, wat deur meer as 100 vissermanne bygewoon is, plaasgevind. Die hoofstroom van klagtes was gemik op die onverwagse sluiting van ou en bekende paaie langs die strande, sonder vooraf waarskuwing en met die ophê van hoë boetes.

Na 'n voormiddag se samesprekings, is 'n komitee vanuit die vissermans geledere saamgestel. Cape Nature se afvaardiging het onderneem om saam met die komitee intens na al die klagtes te kyk en met voorstelle vorendag

te kom. Die afvaardiging het landskaarte van die kuslyn, asook lugfoto's saamgebring. Altwee partye se afgevaardigdes het gesamentlik intens na die situasie gekyk. "Ons het die afgevaardigdes op 'n 4x4 rit geneem sodat hulle fisies kon sien waaroor ons klagtes handel," vertel Pieter du Toit, voorsitter van die vissermanskomitee. "Ek glo ons het ons saak goed gestel en dink ons in nou by 'n 50/50 situasie oor ons probleme."

Cape Nature het na afloop van die vergadering gesê dat hulle binne die volgende 14 dae sal terugkeer. Dit blyk dat 'n volle vergadering dan weer belê sal word om na hulle voorstelle te luister en dit te bespreek. "Voordat hierdie tydperk verstryk het, is daar dus eintlik niks



konkreets op die tafel nie," het Pieter gesê. "Ons wag nou vir die volledige vergadering wat weer gehou gaan word." Pieter het bygevoeg dat dit duidelik is dat Cape Nature se afvaardiging dit ten doel het om by bevredigende oplossings uit te kom.

Die heengaan van 'n Groot man met 'n Groot liefde vir sy Verlosser -Wyle David Roos-

Die onverwagse en skielike afsterwe van David Roos (73) van De Kelders op Woensdag, 23 Februarie 2022 het soos skokgolwe deur die gemeenskap getrek - 'n skamele 4 maande nadat hy met Annetjie (née Liebenberg) op 30 Oktober 2021 in die huwelik bevestig is. David was bekend daarvoor dat hy gereeld as pastoor opgetree het, asook as die aanbieder van oggendgodsdienste by Gansbaai SAPD.

"Ons het by Gansbaai Wimpy vir iets te drinke ingegaan en het nog lekker gesit en gesels," het 'n bedroefde Annetjie aan Gans-Berg Nuus gesê. "Die volgende oomblik het sy kop eenkant toe geval en alles was verby - die dood is wreed." Hulp is ontbied, maar David is op die toneel dood verklaar. Ds Hanri Joubert van die NG-gemeente het Annetjie ondersteun en haar na dr Hendricks se

spreekkamers vir die nodige hulp vergesel.

"Gansbaai se polisie was só lief vir hom en het selfs met ons troue pragtige blomme aan ons gestuur, min wetende dat ons diepe geluk van korte duur sou wees," het Annetjie gesê. "Nou het hulle weer blomme gestuur, maar dié keer vir sy heengaan." Annetjie se gemoed het die oorhand gekry toe sy sê hoe sy vir David en sy tergerey en humor mis. Ds Dirk van Dyk het die egpaar in die huwelik bevestig.

David is op 23 Junie 1948 op Exopo, KwaZulu-Natal gebore. Op 6 Januarie 1966 begin hy sy beroepslewe in die Suid-Afrikaanse Lugmag, waar hy homself as vliegtuigtegnikus kwalifiseer. Na 31 jaar diens tree hy op 30 September 1997 uit diens. In 1998 koop hy 'n erf in De Kelders en in Januarie 2001 verhuis hy en sy oorlede eggenote, Lorna permanent na De Kelders. Die

egpaar was 52 jaar getroud voordat Lorna hom in 2020 ontval het. David het 2 dogters, Michelle in Pretoria en Denize in Ierland. David was die oupa van 6 kleinkinders en 6 agterkleinkinders.

Annetjie, ook 'n bekende Gansbaaier, is op 29 Maart 1945 in Wellington gebore, maar het aan die Weskus grootgeword. Haar oorlede man, Kallie, het haar na 47 huweliksjaare in 2011 ontval. Annetjie het drie kinders, Karl, Sariëtte en Jakkie en het 7 kleinkinders. Haar beroepsaadjie het 38 jaar gelede by Gansbaai se Pelagiese Visserye begin, waar sy op 27 Maart 2021 afgetree het. Spyseniering is een van haar uitstaande kenmerke, met David wat destyds met 'n breë glimlag vertel het dat hy dit reeds agtergekom het.

In Gansbaai is die herdenking van die tragedie van die HMS Birkenhead Troepeskip vir baie jare 'n tradisie - vanjaar op Saterdag, 26 Februarie 2022 was dit die 170ste herdenking wat deur Gansbaai Toerisme gereël is. Die hoofdoel daarvan is om nie van die Birkenhead-tragedie op 26 Februarie 1852 te vergeet nie. Jaarliks is daar ook nasate van die drenkelinge of oorlewendes van die tragedie, wat spesiaal vanaf Engeland kom om die verrigtinge by te woon.

Soos wat die herdenking 'n tradisie geword het, so het Wilfred Chivell se beskikbaarstelling van sy haai- en walvisbesigtigingsbote ook 'n tradisie geword. Hierdie bote vaar na die gewraakte Birkenheadrots. Ds James Gray het die verhaal

van die ramp oor 'n luidspreker aan die gaste vertel en 'n gebed gedoen, waarna blomkrans in die see gegooi is.

Na die bootrit het sommige van die gaste na Dangerpoint Ligtoring vertrek, waar 'n herdenkingsdiens by die Birkenhead-monument om 11:00 gehou is. Verskeie hooggeplaasdes het die diens, wat deur ds Gray waargeneem is, bygewoon.



Die gewyde verrigtinge is soos volg afgesluit: *The Last Post* (trompet); Een Minuut Stilte; *Reveille* (oggend-sinjaal); Kranslegging; Uitspreek van die Seën. Mark Robson het luisterryke agtergrondmusiek met sy doedelsak gespeel. Die pragtige en gedissiplineerde optrede deur die Birkenhead Kadette van Hawston onder leiding van Lt. Dreyer was merkwaardig.

Die belangrikste kenmerk van die tragedie in 1852 was die woorde van Kaptein Salmon wat in die geskiedenisboeke verewig is: *"Women and children first"*!

'Bosberaad' vir Gans-Berg Nuus

Die personeel van Gans-Berg Nuus het op 'n 'Bosberaad' en beplanningssessie op 18 Februarie 2022 na Stanford vertrek - met die eienaar, Michelle van Zyl, wat alles in die geheim beplan het.



Die smaaklike ontbyt in *Stanford's Kitchen* het die samesprekings nog geselliger gemaak. Tevrede personeellede het vandaar na *De Kleine Rivers Valey House* vertrek - met 'n jaarbeplanningslys wat skrik vir niks.

De Kleine Rivers Valey House - 1785
Wat 'n interessante plek om te besoek - die sogenaamde 'Spookhuis', met 'n venster wat oor die Ou Begraafplaas in Stanford uitkyk. 'n Legende lui soos volg: “Een van die eienaars, Samuel Parlbay (1831-1838) was buitengewoon verlief op sy vrou, Hester. Na haar heengaan in 1835, wou hy haar graf van die terras af sien en het haar toe in die begraafplaas begrawe. Die huis het dik mure, 23 kamers, 17 badkamers en is met 'sagte' stene gebou. Die jaartal wat op die kombuisdeur aangebring is, is 1660.

Die huis is in 1785 gebou en was die oorspronklike woning van Sir Robert Stanford. Dan is daar ook nog 'n spesiale kamer van Lady Anne Barnard (Mei 1798). Daar is 'n groot verskeidenheid oudhede wat in die ou huis besigtig kan word.

'Birkenheadbrief' van 1852
Een van die baie interessanthede wat aan Gans-Berg Nuus se personeel uitgewys is, is 'n brief, gedateer 20 Maart 1852. Dit handel oor die tragiese gebeure van die HMS Birkenhead Troepeskip op 26 Februarie 1852. 'n Afskrif van die brief is in die argiewe van Hilton College, Natal in 1994 deur dr Alan Kayle gekry. Hy het 'n nota daarop aangebring: “The above letter is as near as possible a copy of my letter to my father, written as soon as I was sufficiently strong to write. I was not 20 then... - signed: GA Lucas, 17 July 1905.” (Stet)



In die brief word die HMS Birkenhead se vaart vanaf Simonstad tot by die Birkenhead-rots en daarna, volledig beskryf - aldus die dokumentasie wat voorgelê is. Hiermee enkele aanhalings uit die brief:
* *They arrived at Simon's Bay at about 10 am on Monday 23rd Feb 1852 after 47 days on passage...This passage was the fastest of any troopships up to that time...During the passage 4 women died and 3 babies were born.*
* *I went on deck and the first person I met at the top of the companion ladder was the ship's carpenter...I asked him what was the matter...his answer was not*

very consoling: 'We are sinking fast, we have got 13 feet of water in the ship forward.
* *I heard the order to fire the signal guns, the powder however could not be got at, the water having come in so fast.*
* *When I left the ship many poor fellows in the 'Mizzen Rigging' must have been drowned at once...I swam about 100 yards then caught hold of a piece of wreck, rested, then struck out for a large white object, 50 yards off perhaps...It turned out to be one of the paddle box boats turned keel uppermost...I found on it 5 soldiers and 1 sailor.*

So kan groot dele van die interessante brief aangehaal word, maar die spasie laat dit nie toe nie. Die besoek aan Stanford was nogal 'n mondvul, veral met nog 'n oudhede-winkel wat daarna besoek is.

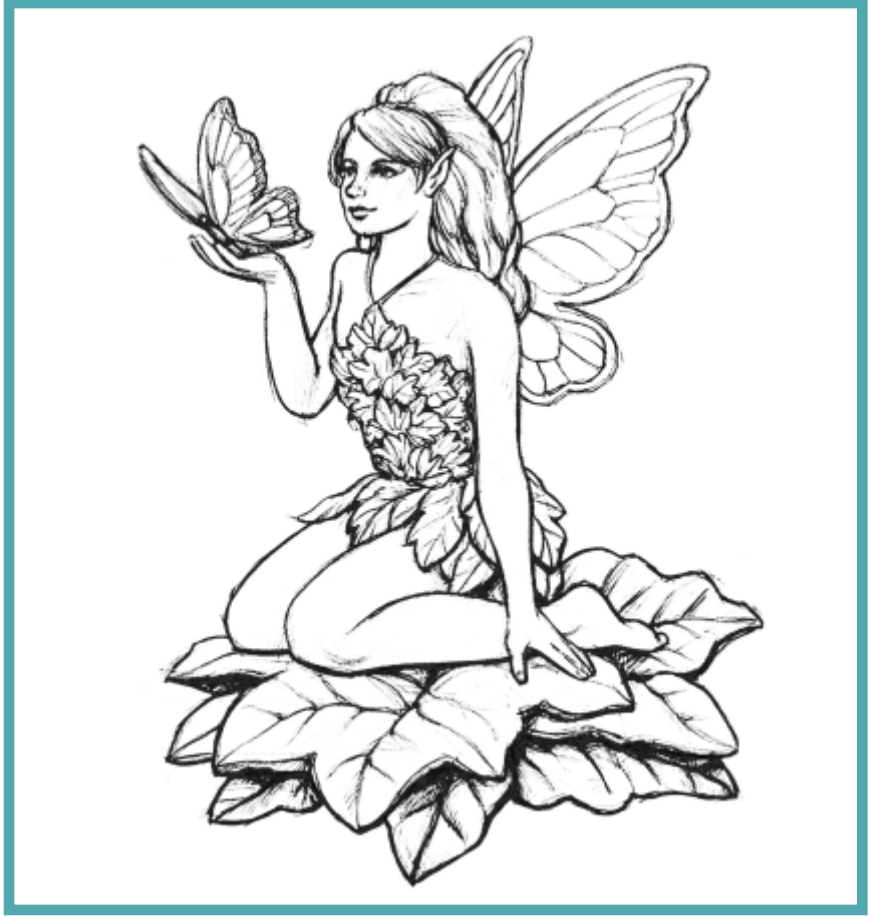

Road Racing is Back!!

The wait has been a long one and keeping motivated to train was a tough one. Anyway, I continued to train but not as often as I should and always felt something was lacking. Trail running events were taking place and I longed for road running to begin.

On 17 January 2022, I noted that the Peninsula 21km would be taking place on 20 February 2022 and decided it was time to get back to serious training and to decide whether I would participate. I was excited and knew I could do it; the training began and on 28 January I felt confident that I could do it. Entry was completed, submitted and confirmed, I was going to run it.

I followed my good eating plan and ran twice a day, first with my dogs Rocky and Rambo – this was a 5km walk / run as dogs should not be running too far and for too long. Second run was a longer run between 8 and 10km. I loved being out there in the beauty of Franskraal, Kleinbaai and Danger Point, I am blessed with this running area. The training went well and soon I was back to my running weight and looking forward to the race.

I left for Cape Town on Friday 18 February, registered in Rondebosch and stayed over in Plumstead for the weekend. Sunday 20 February, I was collected at 04h00 by my dear friend Michelle de Jager and taken to the start of the race in Bergvliet. Procedures are currently



very different and no spectators allowed at the start or at the end, it was a quick drop off and I walked to my starting batch. Due to the COVID regulations we are not allowed to all leave together, we were set off in batches of 250 runners.
