Jacques Groenewald (40), 'n ou bekende in Pearly Beach, het dié dorp onlangs saam met sy filmspan besoek. Jacques bring al van kindsbeen af vakansies daar deur, waar sy ouers 'n vakansiehuis besit. Jacques is die Produksiebestuurder en mede-vervaardiger van die TV-program, *Platteland toe* (VIA DStv-kanaal 147). Hy vertel met trots dat hy sy 40ste verjaarsdag op Pearly Beach gevier het. Die res van die filmspan is Viljé Maritz (Aanbieder) en Leon Barnardt (Kameraman).

Pearly Beach Ontspanningsklub was op 9 Maart 2022 volgepak van gaste wat by netjiese tafels aangesit het. 'n Gesellige atmosfeer het die saal gevul in afwagting vir die filmspan wat moes opdaag. Die koppe het behoorlik gedraai toe die driemanskap by die saal instap - met verbasing om te sien dat hulle drie aangename, vriendelike en spontane manne is - "sonder enige fieterjasies", soos een van die gaste gesê het.

Platteland toe se 'Breinkind'

Jacques Groenewald is die 'breinkind' van die TV-program 'Platteland toe'. Jacques het sy pa, Christo Groenewald, sowat 2 jaar gelede, tydens die piek van die pandemie, in Julie 2020 aan die dood afgestaan. Sy ma, Elize (63) leef nog. "Ek was platgeslaan en niks het meer vir my sin gemaak nie en sy dood het my vir maande lank afgetakel," vertel Jacques. "Ek het egter besef ek baklei teen niks en niks sal hom weer terugbring nie."

Sy pa se woorde aan hom het hom bygebly: "Jy reis die wêreld in, maar jy het nog nooit eers jou eie land verken nie." Jacques het homself afgevra wat hy kan doen om 'n verskil in ons mooie Suid-Afrika te maak, hier waar soveel besighede swaargekry het en die toerisme 'n reuse knou toegedien is?

Sy pa se woorde het die katalisator vir Jacques se gewilde reisprogram, *Platteland toe* geword. In Desember 2020, enkele maande na sy pa se dood, het Jacques en sy vriend, Anthonie Bogas (hoof van ABS Produksies) vergader en 'n voorlegging aan VIA gedoen, met die res wat geskiedenis is.

Die 1ste 2 seisoene van Platteland toe

"Ek het geleer dat moeilike tye ook goeie tye kan word," het Jacques gesê. Wanneer ons die lewe

met 'n goeie gesindheid aanpak, kan ons wel sukses behaal. "My pa het my geleer om op my voete te staan en dat niks onmoontlik is voordat jy nie eers self probeer het nie." *Platteland toe* het hom gewys dat hy die mooiste plattelandse dorpie nou kan ervaar - "dat ek die mooi op kamera kan vasvang en dit met mense kan deel wat ook graag hierdie plekkies wil sien."

Wat kykers nie weet nie

Jacques vertel dat hy, as vervaardiger, saam met die produksiespan deur die land toer - "ek ervaar elke deel van die dorpie wat ons op kamera

vasvang, want ek sê altyd *Platteland toe* is my baba." Hy hanteer nie die kamerawerk, redigering of aanbieding nie, maar sê dat hy 'n oog oor alles hou voordat dit gebeeldsend word. Sy intense betrokkenheid maak die program vir hom uniek.

Het Jacques nog drome?

"Beslis en die eerste een is om aan my volgende TV-konsep te werk, maar dis nog 'n geheim," vertel Jacques. Dan hoop hy ook om nóg episodes van *Platteland toe* te kan maak. "Nog 'n droom van my is om eendag my boek, waaraan ek al jare werk, bekend te stel. Dit is gevoel-stories oor hoe om die lewe ten volle en met 'n positiewe gesindheid aan te pak." Dan droom Jacques ook nog daarvoor om baie leefstyl- en werklikheidsprogramme te skep wat mense regoor die wêreld kan vermaak. Groot drome, maar haalbaar vir so 'n positiewe man wat Pearly Beach en die omgewing baie goed ken en sy kinder- en volwasse vakansies gereeld daar deurgebring het!

Have we lost our Respect?

Gansbaai Community Police Forum



Being the Gansbaai CPF Chairperson, my role is to ensure liaison between Gansbaai SAPS and the community. In addition, the aim of the CPF is to ensure police accountability, transparency and effectiveness in the community.

Recently it has been brought to my attention that a few members of the community who have visited the police station have become very disrespectful, often using offensive language and having abusive behaviour towards Gansbaai SAPS members. Likewise, I have had complaints from



members of the community of Gansbaai SAPS members who have been disrespectful. Both complaints are of concern and we need to understand what is respect to address these issues.

Nobody has the right to use offensive language or have abusive behaviour towards any person. The Gansbaai SAPS is here to help the community and SC Lt Col Winston Coetzee believes strongly in respect and integrity. This means a person must behave ethically and do the right thing, even behind closed doors.

What is Respect?

- Respect is a way of treating or thinking about something or someone. If you respect a person, you admire them and treat them well.
- People should respect each other and no reason is required – no matter the position or age of the person you are dealing with.
- Respect is something that should be given and received by all.
- Respect is important because it sets the proper stage for all our human interactions. Friendship, love and even basic effective communication must all begin with respect.
- Everyone wants to be respected.
- Respect and value yourself, so that the rest of the world recognises you are someone to be respected.
- To earn and deserve respect, though, you must also show respect to others.
- In order to win the respect and consideration of others, be sure to demonstrate respect and consideration for those around you.

Overstrand's treated water is tested by an accredited
external laboratory in accordance with the South
African National Standards (SANS) 241 to ensure quality.
Water samples are taken regularly at all the water
treatment plants and in the reticulation networks. The
drinking water contains no salmonella or e-coli bacteria.



Salmonella is the bacteria that causes Enteric Fever
(Typhoid Fever).

Staat en werkgewers het 'n verantwoordelikheid

Die situasie wat die afgelope week in Robertson tussen seisoenwerkers van Zimbabwe en Lesotho plaasgevind het, kan nie alleen op landbou se skouers geplaas word nie. Dit is ook 'n saak wat deur die Departement Arbeid en Indiensneming en Binnelandse Sake dringend aangespreek moet word. Volgens wetgewing moet alle buitelandse werknemers oor die nodige en wettige dokumentasie beskik. Agri Wes-Kaap vra dat alle werkgewers hulself aan die regte kant van die wet bevind.

"Die aanstelling van onwettige werkers kan nie goedgepraat word nie, maar daar kan nie van landbou verwag word om die polisiering van onwettige werkers toe te pas nie, dit is net nie prakties moontlik nie. Die drakoniese wetgewing dra tans ook nie by tot die oplossing van die probleem nie," meen Jannie Strydom, Hoof Uitvoerende Beampte van Agri Wes-Kaap. Strydom sê die omvang van die probleem is veel groter as die

aanstelling van onwettige werkers. Dit begin reeds deur onwettige buitelanders wat vrylik deur Suid-Afrika se grense beweeg en hulself in die land vestig, en dat dié 'n sosiaal-maatskaplike probleem is.

"As 'n organisasie, vra ons dat daar leiding gegee moet word aangaande die verifikasie van dokumentasie - praktiese oplossings wat landbouproduksie nie sal onderbreek nie. Die landbousektor vra die afgelope twee jaar vir leiding, en daar is steeds geen werkbare oplossing nie."

Agri Wes-Kaap versoek weereens dat alle belanghebbendes om 'n tafel sit om dié enorme probleem aan te spreek.

kursusgangers het hierdie kursus sonder twyfel goeie vrugte afgewerp.

Die kursus is deur Gys Els, Kliniese Sielkundige van Perlemoenbaai aangebied, met die ondersteuning van sy eggenote, dr Lishje Els (Opvoedkundige Sielkundige). "Ons doel met die kursus was om te verduidelik hoe trauma werk en die effek daarvan op mense. Terselfdertyd wou ons ook graag iets in die gemeenskap terugploeg."

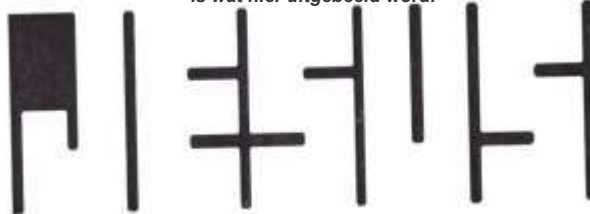
Dit kan wees dat die afgelope pandemie-tydperk, wat steeds nie agter die rug is nie, baie meer trauma by mense opgelewer het as waarvan ons bewus is. Lishje se werk by Laerskool Gansbaai het ons opnuut bewus gemaak van die trauma waaraan ons kinders blootgestel word. "Dit was deel van ons motivering om 'n kursus oor die verstaan en hantering van trauma aan te bied," het Gys gesê. "Die hoofdoel van die kursus is om die kursusgangers die begrip en omvang van die woord 'trauma' te laat verstaan en hoe om dit te

hanteer." 'n Mens moet eers leer om met jou eie trauma-seer te werk en dan met dié van ander. "Jy kan mense nie help as jyself in 'n fase van trauma-pyn verkeer nie en wat jyself nie verstaan of kan verwerk nie."

Gys het ook gesê dat die trauma wat mense beleef, nie noodwendig altyd persoonlik van aard is nie - dit is deel van die mens se gene en grootword-kultuur. Daar moet ook gekyk word na die invloed van verskillende kulture waar dit by trauma-hantering kom. "Dink maar aan ons eie grootword-tyd," het hy gesê. "Dis hoe mans móét wees..., dis hoe vrouens móét wees..., kinders moet gesien en nie gehoor word nie!" Hy sê 'n mens kan byna praat van 'n 'diskoers', 'n 'waarheid' waaraan nie geraak mag word nie! Hierdie 'waarhede' in elke kultuur regeer dan die gemeenskappe. So het elke kultuur sy 'eie' stel reëls, waarmee daar nie op sigself 'n probleem is nie, maar dit kan wel dominant word indien dit nie teenstand duld nie.

Dit is van groot belang dat mense moet leer om 'anders' te kyk. 'n Goeie voorbeeld is die skets agter

op Gys se besigheidskaartjie, wat dalk aan baie bekend is. Met die eerste ('normale') kyk is daar net 'sinnelese' swart strepies op die kaartjie waarteen die kyker homself blind staar. Dan kom die opmerking: "Die letters van die woord op die kaartjie is wit." - wat nou?! Sommige kykers, soos die uwe, sukkel steeds, maar ander glimlag skielik breed met die wete dat hulle die strepiesskets 'anders' gelees het - en daar staan die woord in wit letters so duidelik soos daglig. (Sien foto hiernaas). Lesers kan gerus 'anders' kyk en sien of hulle die woord in wit letters kan sien - Gans-Berg Nuus gaan nie die geheim verkap nie!

Bosbouer, Visserman, Houtwerker... -Johan Rossouw-



Johannes Gideon (Johan) Rossouw (77), 'n voormalige bosbouer, maar 'n bekende en geliefde visserman van ons omgewing, is op 25 Februarie 2022 aan natuurlike oorsake oorlede. 'n Dankdiens is op 4 Maart 2022 deur ds Dirk van Dyk in die

NG-gemeente aangebied.

Johan is op 21 September 1944 te Malmesbury gebore, maar het in die Paarl grootgeword waar sy pa die munisipaliteit se Superintendent van Werke was. Op 24 Desember 1966, bykans 56 jaar gelede, tree Johan met Maryna (née Van den Berg) in die Paarl in die huwelik. Drie dogters is uit die huwelik gebore: Anelda (53) van Botswana, Helene (50) van Heidelberg, Kaap en Maryna (45) van die Paarl. Johan laat 5 kleinkinders, 4 seuns en 1 dogter, agter.

Johan as Bosbouer:

Aanvanklik was Johan vir 2 jaar in die Korttermynversekeringsbedryf werksaam, waarna hy opleiding te Graskop in die destydse Oos-Transvaal (Mpumalanga) as bosbouer deurloop het. Verdere bosbou-opleiding was by die Bosbou Kollege in George en daarna doen hy sy tweede praktiese jaar te Grabouw.

Die gesin verhuis na Louis Trichardt in die destydse Noord-Transvaal (Limpopo) waar hy vir 3½ jaar in die bosbou-plantasies werk. Hulle keer terug na die Wes-Kaap waar Johan vir 16 jaar in beheer van die Riversdale-plantasies is. Vir die laaste 3 jaar van sy bosbou-loopbaan, werk hy as Plantasie-bestuurder (destyds genoem 'Bosbouer') by die Franschhoek-plantasies. In April 1994 tree Johan met vervroegde pensioen af.

Johan as Visserman:

Na Johan se aftrede verhuis hulle permanent na hulle vakansiehuis in Kleinbaai - bykans 30 jaar gelede. Johan het reeds in 1973 die erf gekoop en die vakansiehuis in 1981 gebou waar die gesin hulle vakansies deurgebring het. "Dit is waarom hy hierdie omgewing soos die palm van sy hand geken het," vertel Maryna. "Hy het hier

voltyds begin visvang, maar was sy hele lewe lief vir visvang, hy het selfs as skoolseun al saam met 'n onderwyser in Gordonsbaai visgevang."

Johan het met 'n klein bootjie begin visvang. Nadat hy sy kommersiële lisensie gekry het, het hy elke keer die vorige boot met 'n groter een vervang: Eers was dit *Malgas*, daarna *Roman* en die 3de boot het ook *Roman* geheet. Maryna vertel dat Johan en Johnny Ritter voorheen saam met Oom Roman Groenewald op sy boot visgevang het, vandaar die naam van sy laaste twee bote: *Roman*. Johan se Land Rover wat hy al die jare gebruik het, het hy sowat 18 jaar gelede al gekoop en hom *Potberg* genoem. "Hy het egter nooit sy klein bootjie verkoop nie," vertel Maryna. "Daarmee het hy gereeld op sy eie see toe gegaan en die groter bote net gebruik wanneer vriende saam met hom uitgegaan het." Die klein bootjie se naam was *Piet Maanskyn*, wat sy pa se bynaam was. Johan het tot kort voor sy afsterwe nog alleen see toe gegaan.

Johan as 'Houtwerker':

Maryna sê houtwerk was al die jare 'n

geliefkoosde stokperdjie van Johan - hoe dan nou anders vir 'n 'Bosbouer'? Na sy aftrede in Kleinbaai het hy meer aandag aan sy houtwerk begin gee wanneer hy nie see toe is nie. "Veral die laaste jaar was hy baie bedrywing met houtwerk," vertel Maryna. "Ons huis staan vol tafels en stoele wat deur hom gemaak is." Sy sê hy het ook baie beddens en tafels vir Junior se *Tiekiedraai* gemaak.

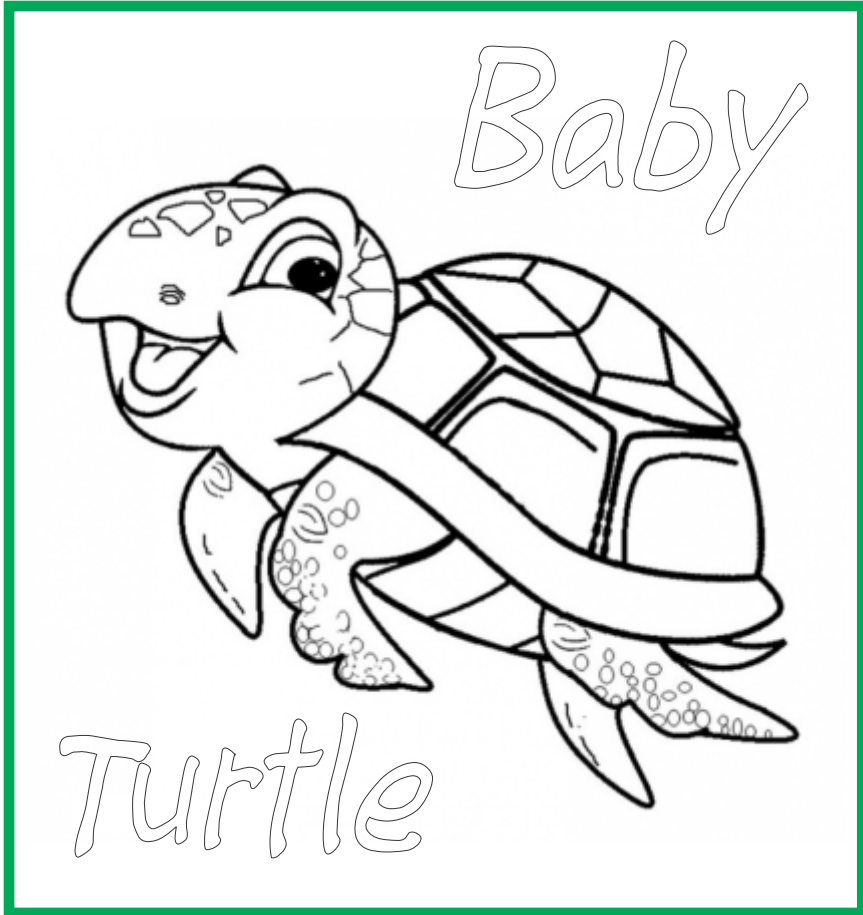
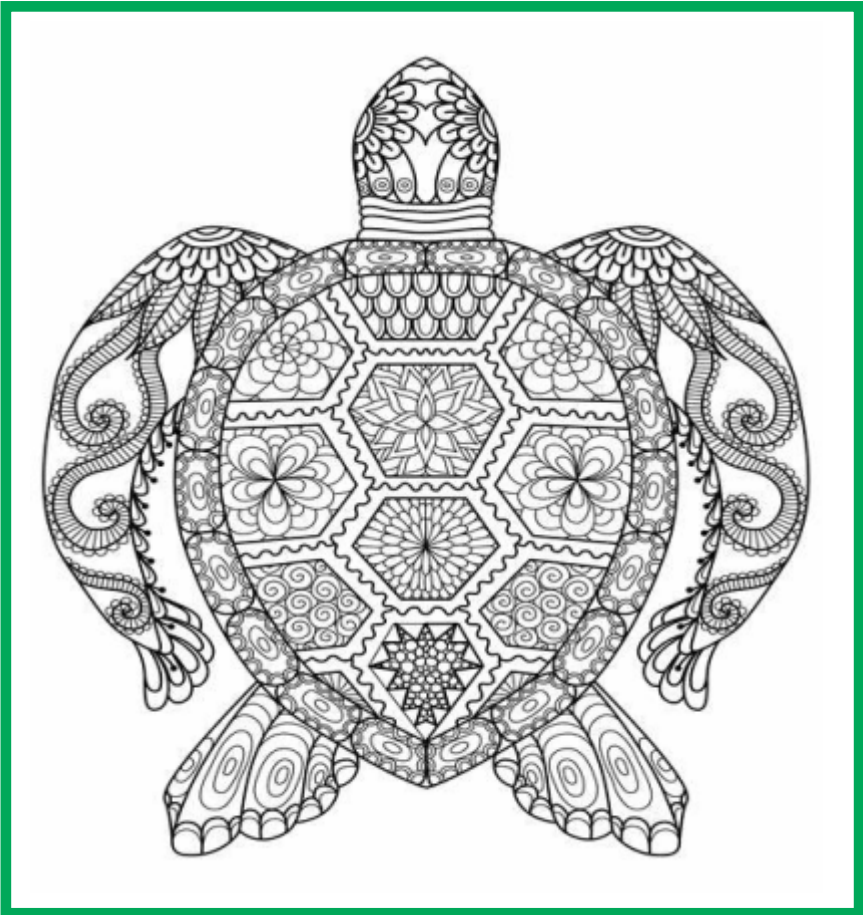

Renosterveld conservation in the Overberg turns 10 years old

-Overberg Renosterveld Conservation Trust (ORCT)-

Founder and Director of ORCT, Odette Curtis-Scott.



In 2012, the Renosterveld of the Overberg had a helping hand for the first time, when a small Trust with big dreams launched. Now the Overberg Renosterveld Conservation Trust (ORCT) turns 10 years old. For founder and Director, Odette Curtis-Scott, this is a dream that seemed impossible 10 years ago. "I still can't quite believe it and must pinch myself

on during these 10 years - showing farmers the incredible diversity and life that exists in these patches."

A mission with a difference

According to Prof Muthama Muasya of the University of Cape Town, the ORCT has one major difference from most other non-profit organisations. "The approach to conservation taken by the ORCT is towards conserving the ecosystem, as opposed to approaches that look at a particular species, like the rhino. The ORCT is therefore conserving not only what we know above the ground, but also below the ground, and the interaction of the complexities of the ecosystem."

A game-changer for the Trust came with the launch of conservation easements, a mechanism that gives support to farmers to protect their Renosterveld, by signing title deed restrictions. In return, the ORCT helps with habitat restoration and management, which can include clearing of invasive alien vegetation, fencing to improve livestock management on the veld, erosion control and ecological burns, among others.



Renosterveld of the Overberg'

Odette co-authored the guide, which not only showcased thousands of plant and animal species but also sought to raise awareness of the plight of Renosterveld. To add to this, the ORCT is now developing the world's first Renosterveld herbarium, based at Haarwegskloof, to collect every known species found within the Overberg's Renosterveld.

As an iconic Fynbos and Renosterveld-dependent species, the ORCT is working to protect Black Harriers. This endemic, charismatic bird of prey is listed as Endangered, with only around 1 300 mature individuals remaining in the world. The Trust is placing satellite tags on breeding adults, to learn more about their foraging habits and their use of the landscape.

Here's to another 10 years

Odette says, "We could not have done any of this without our farming partners, nor the supporters and donors who have provided such vital support over these 10 years. Still, much work remains." For Dirk van Papendorp, there's so much reason to continue this mission. He says, "You're a better person after you spend time in Renosterveld reconnecting with nature." And as the ORCT's Conservation Manager, Grant Forbes, says, "We are working against the clock. If we don't continue to act, Renosterveld could be lost forever."

to remember this is real. We have made major inroads towards protecting Renosterveld over this time."

Renosterveld is the richest bulb habitat on earth but is also one of South Africa's most threatened ecosystems. Since the advent of farming technology the plough, 95% of Lowlands Renosterveld has been removed and replaced for agricultural development. The 5% of Renosterveld that remains is severely fragmented - with patches situated on private land in valleys and on hills too steep or rocky to plough.

Odette says, "When I first started spending time in Renosterveld, I saw there was a big gap that needed to be filled. At the time, few farmers saw the value in their Renosterveld, which was seen as the ugly sister to Fynbos. That's what we've focused

Farmer Dirk van Papendorp, who has been Chair of the Trust since its inception, says that this support to farmers is the foundation for success. "I am sure that as a Trust we are doing the right thing working with landowners. This is how we'll bring about change." Already 20 conservation easements have been signed, with around 6 000 hectares now protected via title deed restrictions.

But this is only the beginning. Odette says, "My vision is to one day see our easement signage across all farms in the Overberg with Renosterveld on it. I'd love to see landowners looking at the bigger picture, looking at their farms as part of a bigger landscape where it's clear that everything you do impacts on everything else."

Supporting Renosterveld research

The ORCT has also made other important inroads. In 2014 they were given the management responsibility of Haarwegskloof Renosterveld Reserve by WWF South Africa. Haarwegskloof is home to the largest connected stretch of Renosterveld left in the world. Odette and her team converted the old farmhouse into a research centre for students to study this ecosystem, and then converted an old dairy into a self-catering guest house for visitors.

In 2020, after 5 years of research, the first Renosterveld field guide was launched, called the 'Field Guide to

Taurus Cape Kelp se groot groep het gesorg vir water en appels, wat baie welkom was in die bloedige hitte.

Doulene verduidelik dat sy net op vrywilligers kan steun om haar te help om 'n sukses van hierdie projek te maak. "Ek kan nie anders as om baie trots op my familie te wees nie," sê sy. "Hulle het van die begin af aan elke Coastal Clean-up deelgeneem," vertel sy. Byname is hierdie flukse familiespan Lezelle Els, Nicolette Otto, Theuns Otto, Karlien Otto, Xavier Otto en Riaan Theart.

Dan is daar nog die Van Vuuren en Havenga families wat by Doulene ingeskakel het en Taurus Cape Kelp se personeel, veral Lucille Bensch, wat 'n groot rol in die sukses van hierdie projek gespeel het. "Ons was ook bevoorreg om hierdie keer 'n lid van die Departement van

Omgewingsake, Votiswa Matkanza, as deel van die groep te kon hê," vertel Doulene.

Kom ons hou Gansbaai skoon -Blompark-bejaardes by herwinning betrek-



Blompark se bejaardes is onlangs gemotiveer om aktief by herwinningsprojekte betrokke te raak. Raadsdame Riana de Coning (Wyksraads lid van Wyk 14) het op Dinsdag, 15 Maart 2022 saam met mnr J Solomons (Senior Bestuurder: Operasionele Dienste) 'n groep bejaardes by Silwerjare Dienssentrum toegesprek.

“Die noodsaaklikheid van herwinning is aan hulle verduidelik,” het Raadsdame Riana gesê. “Buiten vir die estetiese waarde van netjiese strate in jou woongebied, moet die gevolge van vullisstorting in die oseane, riviere en seelewe altyd in gedagte gehou word.” Sy het Dyer Island Conservation Trust as 'n voorbeeld voorgehou. “Hulle het 'n paar jaar gelede 'n gemeenskapsprojek geloods vir die maak van items uit koerant-herwinning,” het sy gesê.

Silwerjare Dienssentrum het, onder leiding van Mariaan Burger, reeds met 'n soortgelyke projek begin. Die bejaardes kom Dinsdagoggende bymekaar om herwinnings-inkopiesakke te maak. Tydens die besoek is die volgende aan die bejaardes verduidelik:


Dis hoe herwinning werk
Overstrand Munisipaliteit voorsien huishoudings van deursigtige plastieksakke wat hulle kan gebruik om van hul herwinbare afval ontslae te raak. Hierdie sakke moet uitgeplaas word op dieselfde geskeduleerde dag waarop afval normaalweg in die onderskeie areas afgehaal word. Gansbaai beskik oor 'n Materiaal Herwinnings-fasiliteit waar alle herwinbare materiaal gesorteer en verwerk word. Vir elke deursigtige plastieksak wat op daardie dag opgetel word, kry inwoners 'n gratis sak ter vervanging.

Moets en moenies
Herwinning is heel eenvoudig, mits jy by die goue reëls hou:
**'Nat afval', met ander woorde goed wat nie herwin kan word nie, gaan in die swart sak en herwinbare items in die deursigtige sak: “Dit beteken dat slegs skoon, droë herwinbare items soos plastiek- of glasbottels, blikkies, melkkartonne en items wat van papier of karton gemaak is, in die deursigtige sak geplaas moet word,” is aan die bejaardes verduidelik.
**Om te verhoed dat vullisverwyderaars beseer word, draai glasskerwe asseblief eers in koerantpapier toe voordat jy daarmee wegdoen.
**Let daarop dat tuinafval (grassnysels, blare, ens.) in 'n afsonderlike groen sak geplaas moet word sodat daardie afval ook vir komposterings herlei kan word.
**Onthou dat vullissakke - hetsy swart, deursigtig of groen - slegs uitgeplaas mag word op die dae wat vir vullisverwydering geskeduleer is: Hulle mag nie voor die tyd uitgeplaas word nie. “Om die waarheid te sê, om 'n vullissak oornag op 'n sypaadjie te los in 'n geïdentifiseerde probleemgebied, is strafbaar,” is verduidelik.

Sonder 'n deursigtige sak of benodig jy nog?
Weens die vraag en gevolglike druk op beskikbare voorraad kan dit gebeur dat sommige huishoudings nie altyd 'n vervangende deursigtige sak op vullisverwyderingsdag ontvang nie. Daar is ook gevalle waar huishoudings, weens volume, dalk meer sakke benodig. In gevalle soos hierdie kan vervangende sakke by die Gansbaai Munisipale kantoor afgehaal word. As daar oor naweke van oormatige herwinbare items ontslae geraak moet word, maak asseblief gebruik van die naaste oorlaastasie of munisipale aflaaifasiliteit.
Raads lid Riana het ook 'n pleidooi gerig dat bejaardes teenwoordig hulle bure, vriende en kinders moet motiveer om nie somer vullis in die strate of langs die geel voorsiene houe te stort nie. Daar word soveel moeite deur Overstrand Munisipaliteit gedoen dat Blompark 'n pragtige en versorgde area moet wees, met netjiese strate - inwoners moet asseblief ook hulle kant bring en geen rommel strooi nie.
