## VENDOR INFORMATION SHEET

**Gansbaai won the 2015 World Responsible Tourism award. Please ensure that your products are environmentally friendly, ethically produced and your packaging is biodegradable and not plastic or polystyrene. This includes straws, cups, knives and forks and plates.**

### STALLS:

- Allocated space for stalls is 3m x 3m. (Own power required)
- Stall areas will be marked and allocated 9 am on the Friday.
- All stalls to stay within the designated stall area.
- Only handmade crafts and / or fresh food will be considered for stalls.
- Limited power, so ensure that you have your own power worked out.
- **You are required to be there for both days of trading.**
- All stalls must be ready for trading 11:30 am, 24 Friday September and 09:30 am, Saturday 25 September. All stalls **MUST** trade till 8 pm both days of the festival. (**No early breakdown** but may trade later.)
- Set up from **9:00 am Friday 24 September 2021.**
- All stall holders must keep their trading area clean and leave it as found.
- First come first serve as limited space is available.
- All packing must be bio-degradable, no single use plastics, polystyrene and balloons allowed.
- All Stalls to comply with Covid-19 Regulations.

### FOOD STALLS:

- All vendors that handle consumables (even totally sealed and not freshly prepared) must produce a valid health clearance certificate and must comply with the Health Act 63, 1977. Please submit this with your application.
- All food vendors to comply with the rules of the Overstrand District Municipality for food stall holders.
- Health Certificates can be applied for at your local municipal office at a once-off fee.
- All food market vendors must have a basin of water for hand washing, and a rubbish bin.

### CREDIT CARD FACILITIES:

- Vendors to supply their own credit card facilities.

### PAYMENTS:

- Upon payment vendors will be provided with a receipt of Payment. Please bring this receipt with you as you may be asked to display it.
- A stall will only be finalized when payment is received.
- On cancellation of the festival due to Covid-19, a full refund will be done.
- **Please book and pay on time to avoid disappointment and late booking premium. Late booking premium is charged at normal rate plus 50 %.**
