Terms and Conditions of Service

1.1 These Terms and Conditions to Prevail

These terms and conditions (hereinafter referred to as "this agreement") shall, when read together with the Application Form and any schedule thereto, constitute the whole of the agreement between The Computer Hut CC reg.no.CK 2009/092539/23 ("TCH") and the Client.

1.2 Charges

The Computer Hut reserves the right to adjust installation & service charges at their sole discretion. Existing Clients will receive one month's notice relating to service charge adjustments.

1.3 Termination

The agreement shall continue indefinitely and shall be terminable on the expiry of one calendar month's written notice given by either party to the other. On termination of a service, The Computer Hut will, at its own discretion, buy back any new (less than 6 months old), working radio equipment. The Computer Hut will assess the buy-back value and inform the client.

1.4 Client's Obligations

The Client may not at any time use the service in contravention of any South African law. In particular, the Client undertakes to familiarize itself and ensure that it is kept continuously apprised of all South African law, in force from time to time, which has any bearing on the service and/or its use. The Computer Hut has no obligation to assist the Client in this regard. Please note that should a client be guilty of excessive use of bandwidth (in of the package's specific FAIR USAGE POLICY limit), the package's service speed will be lowered to the minimum for the rest of that month.

1.5 Warranties

The Computer Hut does not warrant or guarantee that the information transmitted by and/or available to the Client by way of the service.

1.5.1 Will be preserved or sustained in its entirety;

1.5.2 Will be suitable for any purpose;

1.5.3 Will be free of inaccuracies or defects or bugs or viruses of any kind, and The Computer Hut assumes no liability, responsibility or obligations in regard to any of the foregoing exclusions.

1.6 Exclusion of Liability

1.6.1 Except as otherwise expressly provided herein to the contrary, The Computer Hut shall not be liable to the Client or any third party for any loss or damage of whatsoever nature and/or howsoever arising (including consequential or incidental loss or damage which shall include but shall not be limited to loss to property or of profit, business, goodwill, revenue or anticipated savings)

1.7 Support and Maintenance

1.7.1 The client is not entitled to any free computer support and/or maintenance. However, The Computer Hut's help-desk will give you free assistance on 028 384 1443 or 0766 718 630 with internet connection problems related to The Computer Hut's network from 08:00 to 18:00. If the problem is not related to The Computer Hut's network, a minimum fee of R150 per 15min will be charged. Telephonic support for your Internet Connection will be given only for Windows 7 to Windows 10 OS platforms. Any third-party networking or Internet client or server software will not be supported by The Computer Hut

1.7.2 The Computer Hut cannot be held liable for any damage to computer equipment during and after installation.

1.7.3 The Computer Hut will only set up your configuration on a Standard Windows 2000/XP/Vista/Windows 7 machine running Outlook/Outlook Express.

1.7.4 The Computer Hut shall not set up a connection on your system if it is running third-party networking or 'firewall' software. If you are unaware of it and we encounter such software during an installation then additional (hourly) charges will apply (including, but not limited to, your system administrator/IT manager's services, as required).

1.7.5 For call-outs involving "connection problems", a minimum call-out fee of R250 will be charged. In the event that the fault is due to faulty installation, there will be no extra charge. Faulty hardware will be replaced under warranty (a one-year warranty applies) but an hourly installation rate of R150 will apply. In the event that the call-out issue is related to your software (including Windows); hardware; power supply; damage; tampering or user error - service charges will apply including mileage. Charged at R250ph and R3.50/km respectively.

1.8 Charges & Payment
