## Terms and Conditions

### Overberg Crossword Challenge Rules (Extended Version)

The Promoter and its Partner are hosting a crossword challenge where Participants can enter the Competition to win a Cash Prize, following the Competition Rules outlined below.

#### 1. Interpretation

In these Competition Rules, the following definitions apply (unless the context indicates a contrary intention):

- "The Act" means the Consumer Protection Act, 68 of 2008.
- "Competition Rules" means these rules, as per Section 36 of the Act.
- "The Competition" is as described in the Competition Rules.
- "The Participant" means an individual who enters the Competition and meets the criteria set out by the Promoter.
- "The Promoter" means Xplorio.
- "The Partner" means Gans-Berg-Nuus News / News.
- "The Prize" is further described in clause 4.
- "The Winner" means a Participant who is successful in the Competition and is notified as such by the Promoter in terms of clause 7.
- "Redeemable Period" means the time allocated for The Winner to redeem their Prize.

- Entries must be submitted via WhatsApp using a photo of the Completed crossword puzzle on an original hard copy of the Gans-Berg Nuus / News.

### 6. Winner Announcement:

- After the closing date, the first correct entry selected randomly will win the cash Prize.
- There will be one Winner
- The Prize allocation is final, non-negotiable, and non-transferable.
- The Winner will be selected at random for the correct crossword puzzle.
- The Winner will be contacted telephonically within three weeks of the closing date.
- The Winner must present a copy of the Gans-Berg Nuus / News containing the winning entry to claim the cash Prize.
